Central Georgia EMC Keeps Rates Low

The Georgia Public Service Commission recently released the Winter 2017 Residential Rate Survey. The survey contains results for the 94 electric providers in Georgia, including all electric cooperatives, municipalities, and Georgia Power Co., based on the total electric bill amounts for 2,000 kilowatt-hours (kWh), 1,500 kWh, 1,000 kWh, and 500 kWh.

Central Georgia Electric Membership Corporation (CGEMC) ranked as the lowest-cost electric provider in the state at the 2,000-kWh level and third lowest at the 1,500-kWh level. The average CGEMC customer-owner uses approximately 1,800 kWh per month, allowing them to enjoy the lowest rates for their energy dollars.

"Keeping our rates low and our level of service high is our commitment to our customer-owners," says Central Georgia EMC President/CEO George L. Weaver. Fees may be assessed when a seal is cut or removed by an unauthorized party, including licensed electricians.

Before summer heat returns, consider replacing your HVAC system with a more energy-efficient model. The following 2017 rebates are available to help you upgrade your existing system and potentially reduce your energy use:

Converting from a natural gas furnace to a 16 SEER or greater traditional electric heat pump or VRF system.	\$400
Converting from a natural gas furnace to a system that is less than 16 SEER traditional electric heat pump.	\$250
Replacing an existing heat pump or electric furnace	\$400

with a 16 SEER or greater traditional heat pump or VRF conversion/add-on.

Being Green Is Simple with Green Power EMC

Our Green Power initiative offers an easy way to participate in a green way of life. With the help of Green Power EMC and the support of our customerowners, CGEMC is able to offer a green choice that utilizes electricity generated from biomass resources. Methane gas, a landfill byproduct, is reclaimed and harnessed to create clean and sustainable energy.

Landfill gas generators use the methane produced from the natural breakdown of organic wastes at the landfill site to produce clean, renewable energy while removing harmful methane from the environment.

Members who are interested in participating in alternative energy sources through the Green Power program may purchase a block (150 kWh) of energy on a first-come, first-served basis. These limited blocks are available at an additional cost of \$4.50 per month.

Product Content Label

The product is sold in blocks of 150 kilowatt-hours (kWh). The product will be made up of the following renewable resources.

Making CENTS of Solar

As featured in the April edition of News & Views, Central Georgia EMC continues to offer rates among the lowest in the state. This is great news for the typical CGEMC customer, but it can pose a challenge for those considering installation of solar generation. Low electric rates mean a longer payback period to offset the initial investment required for rooftop solar panels.

Our current net metering tariff, which includes a \$7.00 per kW (AC) solar capacity charge, is designed to ensure customers without solar facilities are not forced to subsidize the cost of providing service to those with interconnection agreements. Beginning this summer, a time-of-use (TOU) pricing option will provide customers, including those with interconnected solar, the potential to realize additional savings by making more informed decisions about their energy consumption and/or production patterns. TOU pricing will encourage customers to focus on off-peak energy consumption, thus helping avoid the use of less efficient generation sources.

Investment, payback period, life expectancy, maintenance, and convenience are all factors to consider when evaluating solar offerings. If you are thinking about installing solar at your home, be sure to contact CGEMC for more information about options and requirements.
